# **AFSCME Members Get It Done!**

This month, I was reminded of what our union can accomplish when we show up in full force.

In Howard County, library system employees won their union by a sweeping margin (151-19)! They organized together and got it done. Their union siblings in AFSCME Locals 1810, 3080, 3085, and 3888 (which represent those who work for Howard County) showed up to lend a hand to help make this happen, reaching out to their networks and encouraging library workers they knew to join our union.

The state legislature is also in session, and AFSCME members are taking action! With several collective bargaining bills on the line, AFSCME members are showing up to testify and speak with their legislators from all over the state. Our actions are working. Our bill to grant collective bargaining rights to supervisors across the state is moving ahead. And we couldn't have done this without all the members who took action, came to Annapolis, and spoke out.

When we show up in Annapolis or at a school board or council meeting, it sends a strong message that the people that do the work — at a school or college, in a city, in a county, or for the State — are in the house and are the experts on the work we do. Our presence makes it happen! We have six more weeks to go until the legislative session is over, so let's keep it going!

This month, we ratified our contract for 20,000 state employees in Units A, B, C, D, F, and H! Over 99% voted in favor of the new contract. Thanks to the hard work of the AFSCME Maryland bargaining team and everyone who voted, we have secured pay increases, additional benefits, and a number of workplace improvements in the agreement.

# HoCo Library Workers United: Welcome to the AFSCME Family!

On Thursday, February 15, over 200 library workers at the Howard County Library System won their union election! Workers voted 151-19 in favor of forming a union to have a protected voice at work, advocate for fair wages and job protections, and address issues such as short staffing and unsafe work environments.

The members of HoCo Library Workers United are joining the AFSCME Maryland family, where we already represent workers at the Enoch Pratt Free Library, the Baltimore Museum of Art, and more! And in Anne Arundel County, library workers there are seeking to form a union with AFSCME.

The Library Workers Empowerment Act (HB 609/SB 591) is currently making its way through the legislative process. **Come out to our remaining Annapolis Lobby Nights** to help us get this bill passed so all library workers can enjoy the right to collectively bargain!

# State Supervisors: Vote Yes for AFSCME Maryland!

SB 192/HB 260 (which would grant collective bargaining rights to state supervisors in Unit S) has passed important milestones during this session! If you know any supervisors, tell them to sign the "Vote Yes" card to secure our union once this bill passes!
